1. Aims

This policy aims to show our commitment to meeting our obligations with regards to school attendance, including those laid out in the Department for Education's (DfE's) statutory guidance on <u>working together to improve school attendance (applies from 19 August 2024)</u>, through our whole-school culture and ethos that values good attendance, including:

- Setting high expectations for the attendance and punctuality of all pupils
- Promoting good attendance and the benefits of good attendance
- Reducing absence, including persistent and severe absence
- Ensuring every pupil has access to the full-time education to which they are entitled
- Acting early to address patterns of absence or lateness
- Building strong relationships with families to ensure pupils have the support in place to attend school

We will also promote and support punctuality in attending school.

2. Legislation and guidance

This policy is based on the Department for Education's (DfE's) statutory guidance on <u>working together to improve school attendance (applies from 19 August 2024)</u> and <u>school attendance parental responsibility measures</u>. The guidance is based on the following pieces of legislation, which set out the legal powers and duties that govern school attendance:

- Part 6 of the Education Act 1996
- Part 3 of the Education Act 2002
- Part 7 of the Education and Inspections Act 2006
- The Education (Pupil Registration) (England) Regulations 2006 (and 2010, 2011, 2013, and 2016 amendments)
- The School Attendance (Pupil Registration) (England) Regulations 2024

<u>The Education (Penalty Notices) (England) (Amendment) Regulations 2013 and the 2024 amendment</u> This policy also refers to the DfE's guidance on the school census, which explains the persistent absence threshold.

It also refers to:

- School census guidance
- Keeping Children Safe in Education
- Mental health issues affecting a pupil's attendance: guidance for schools

3. Roles and responsibilities

3.1 The governing board

The governing board is responsible for:

- Setting high expectations of all school leaders, staff, pupils and parents
- Making sure school leaders fulfil expectations and statutory duties, including:
 - Making sure the school records attendance accurately in the register, and shares the required information with the DfE and local authority
 - Making sure the school works effectively with local partners to help remove barriers to attendance, and keeps them informed regarding specific pupils, where appropriate
- Recognising and promoting the importance of school attendance across the school's policies and ethos
- Making sure the school's attendance management processes are delivered effectively, and that consistent support is provided for pupils who need it most by prioritising staff and resources
- Making sure the school has high aspirations for all pupils, but adapts processes and support to pupils' individual needs
- Regularly reviewing and challenging attendance data and helping school leaders focus improvement efforts on individual pupils or cohorts who need it most
- Working with school leaders to set goals or areas of focus for attendance and providing support and challenge
- Monitoring attendance figures for the whole school and repeatedly evaluating the effectiveness of the school's processes and improvement efforts to make sure they are meeting pupils needs
- Where the school is struggling with attendance, working with school leaders to develop a comprehensive action plan to improve attendance

- Making sure all staff receive adequate training on attendance as part of the regular continued professional development offer, so that staff understand:
 - The importance of good attendance
 - That absence is almost always a symptom of wider issues
 - The school's legal requirements for keeping registers
 - The school's strategies and procedures for tracking, following up on and improving attendance, including working with partners and keeping them informed regarding specific pupils, where appropriate
- Making sure dedicated training is provided to staff with a specific attendance function in their role, including in interpreting and analysing attendance data
- Holding the headteacher to account for the implementation of this policy

3.2 The headteacher

The headteacher is responsible for:

- The implementation of this policy at the school
- Monitoring school-level absence data and reporting it to governors
- Supporting staff with monitoring the attendance of individual pupils
- Monitoring the impact of any implemented attendance strategies
- Issuing fixed-penalty notices, where necessary, and/or authorizing the designated senior leader for attendance to be able to do so
- Working with the parents of pupils with special educational needs and/or disabilities (SEND) to
 develop specific support approaches for attendance for pupils with SEND, including where school
 transport is regularly being missed, and where pupils with SEND face in-school barriers
- Communicating with the local authority when a pupil with an education, health and care (EHC) plan has falling attendance, or where there are barriers to attendance that relate to the pupil's needs
- Communicating the school's high expectations for attendance and punctuality regularly to pupils and parents through all available channels

3.3 The designated senior leader responsible for attendance (the deputy head)

The designated senior leader is responsible for:

- Leading, championing and improving attendance across the school
- Setting a clear vision for improving and maintaining good attendance
- Evaluating and monitoring expectations and processes
- Having a strong grasp of absence data and oversight of absence data analysis
- Regularly monitoring and evaluating progress in attendance
- Establishing and maintaining effective systems for tackling absence, and making sure they are followed by all staff
- Liaising with pupils, parents/carers and external agencies, where needed

- Building close and productive relationships with parents to discuss and tackle attendance issues
- Creating intervention or reintegration plans in partnership with pupils and their parents/carers
- Delivering targeted intervention and support to pupils and families

3.4 Class teachers

Class teachers are responsible for recording attendance for both morning and afternoon sessions on a daily basis, using the correct codes (see Appendix 1), and submitting this information to the school office by 8:50am and 1:15pm.

3.5 School admin staff

School admin staff will:

- Take calls from parents about absence on a day-to-day basis and record it on the school system.
- Refer calls from parents to the deputy head in order to provide them with more detailed support on attendance
- Record on the school register how many minutes late a child is.

3.6 Parents/carers

Where this policy refers to a parent, it refers to the adult the school and/or local authority decides is most appropriate to work with, including:

- All natural parents, whether they are married or not
- All those who have parental responsibility for a child or young person
- Those who have day-to-day responsibility for the child (i.e. lives with and looks after them)

Parents/carers are expected to:

- Make sure their child attends every day on time (8:45am)
- Call the school to report their child's absence before 8:45am on the day of the absence (and each subsequent day of absence), and advise when they are expected to return
- Provide the school with more than 1 emergency contact number for their child
- Ensure that, where possible, appointments for their child are made outside of the school day and if this is in the school day parents/carers may be asked for evidence.
- Keep to any attendance contracts that they make with the school and/or local authority
- Seek support, where necessary, for maintaining good attendance, by contacting Mrs Aspinall, on the contact details above.

3.7 Pupils

Pupils are expected to:

Attend school every day, on time

• Keep to any attendance contract that is made between parents, children and school.

4. Recording attendance

4.1 Attendance register

We will keep an electronic attendance register, and place all pupils onto this register.

We will take our attendance register at the start of the morning (8:45) and afternoon session (1:00) of each school day. It will mark whether every pupil is:

- Present
- Absent due to illness
- Attending an approved off-site educational activity
- Unable to attend due to exceptional circumstances

See appendix 1 for the DfE attendance codes.

We will also record:

- Whether the absence is authorised or not
- Whether a child is on a part time timetable
- The nature of the activity if a pupil is attending an approved educational activity
- The nature of circumstances where a pupil is unable to attend due to exceptional circumstances

We will keep every entry on the attendance register for 3 years after the date on which the entry was made.

Pupils must arrive in school by 8:45am on each school day.

The register for the first session will be taken at 8:45am and will be kept open until 8:50pm.

4.2 Unplanned absence

The pupil's parent/carer must notify the school of the reason for the absence on the first day of an unplanned absence by 8:45am or as soon as practically possible by calling the school admin staff.

We will mark absence due to illness as authorised unless the school has a genuine concern about the authenticity of the illness.

If the authenticity of the illness is in doubt, the school may ask the pupil's parent/carer to provide medical evidence, such as a doctor's note, prescription, appointment card or other appropriate form of evidence. We will not ask for medical evidence unnecessarily.

If the school is not satisfied about the authenticity of the illness, the absence will be recorded as unauthorised and parents/carers will be notified of this in advance.

4.3 Planned absence

Attending a medical or dental appointment will be counted as authorised as long as the pupil's parent/carer notifies the school in advance of the appointment.

However, we encourage parents/carers to make medical and dental appointments out of school hours where possible. Where this is not possible, the pupil should be out of school for the minimum amount of time necessary.

The pupil's parent/carer must also apply for other types of term-time absence as far in advance as possible of the requested absence. Go to section 5 to find out which term-time absences the school can authorise.

4.4 Lateness and punctuality

A pupil who arrives late:

- Before the register has closed will be marked as late, using the appropriate code
- After the register has closed will be marked as absent, using the appropriate code, the amount of minutes late will be recorded on the register system.
- Lateness will be monitored regularly. If lateness becomes a concern then a letter will be sent to parents/carers informing them how many times a child has been late in a period of time and the minutes missed.
- If lateness continues after a letter has been received, then a meeting will arranged to offer support.

4.5 Following up unexplained absence

Where any pupil we expect to attend school does not attend, or stops attending, without reason, the school will:

- Call the pupil's parent/carer on the morning of the first day of unexplained absence to ascertain the reason. If the school cannot reach any of the pupil's emergency contacts, the school may try and contact the family via email or text, or speak to peers. The deputy head may carry out a home visit to try and determine the location of a missing pupil.
- Identify whether the absence is approved or not
- Identify the correct attendance code to use and input it as soon as the reason for absence is ascertained this will be no later than 5 working days after the session
- Call the parent/carer on each day that the absence continues without explanation to ensure proper safeguarding action is taken where necessary. If absence continues, the school will consider involving an education welfare officer
- Where appropriate, offer support to the pupil and/or their parents to improve attendance
- Identify whether the pupil needs support from wider partners, as quickly as possible, and make the necessary referrals
- Where support is not appropriate, not successful, or not engaged with: penalty notices or other legal intervention may take place.

4.6 Reporting to parents/carers

The school will regularly inform parents about their child's attendance and absence levels at the termly parents' evenings and the end of year report. For children with poor attendance and punctuality or those who are causing concern reporting will take place more frequently, by telephone, letter or in meetings such as contracts, CAFs or SEND reviews.

5. Authorised and unauthorised absence

5.1 Approval for term-time absence

The headteacher will allow pupils to be absent from the school site for certain educational activities, or to attend other schools or settings.

The headteacher will only grant a **leave of absence** to a pupil during term time if the request meets the specific circumstances set out in the <u>2024 school attendance regulations</u>. These circumstances are:

- Taking part in a regulated performance, or regulated employment abroad
- Attending an interview
- Study leave
- A temporary, time-limited part-time timetable
- Exceptional circumstances

A leave of absence is granted at the headteacher's discretion, including the length of time the pupil is authorised to be absent for.

We define 'exceptional circumstances' as

- death of parent/carer or sibling of the pupil
- life threatening or critical illness of parent or sibling of the pupil
- parent/carer recuperation and convalescence from critical illness or surgery (leave request to be made within 6 months of recovery and medical evidence required)

Family emergencies need careful consideration. It is not always in the best interest of the child, nor appropriate for them to miss school for family emergencies that are being dealt with by adult family members. Being at school, friendships and support from staff can provide children with stability and care during difficult times. The routine of school can provide a safe and familiar background during times of uncertainty.

As a leave of absence will only be granted in exceptional circumstances, it is unlikely a leave of absence will be granted for the purposes of a family holiday.

The school considers each application for term-time absence individually, taking into account the specific facts, circumstances and relevant context behind the request.

Any request should be submitted as soon as it is anticipated and, where possible, at least 2 weeks before the absence, and in accordance with any leave of absence request form, accessible via the office. The deputy headteacher may require evidence to support any request for leave of absence.

Valid reasons for authorised absence include:

- Illness and medical/dental appointments (see sections 4.2 and 4.3 for more detail)
- Religious observance where the day is exclusively set apart for religious observance by the religious body to which the pupil's parents belong. If necessary, the school will seek advice from the parents' religious body to confirm whether the day is set apart
- Traveller pupils travelling for occupational purposes this covers Roma, English and Welsh gypsies,
 Irish and Scottish travellers, showmen (fairground people) and circus people, bargees
 (occupational boat dwellers) and new travellers. Absence may be authorised only when a traveller
 family is known to be travelling for occupational purposes and has agreed this with the school, but
 it is not known whether the pupil is attending educational provision

Other reasons the school may allow a pupil to be absent from the school site, which are not classified as absences, include (but are not limited to):

- Attending an offsite approved educational activity, sporting activity or visit or trip arranged by the school
- Attending another school at which the pupil is also registered (dual registration)
- Attending provision arranged by the local authority
- If there is any other unavoidable cause for the pupil not to attend school, such as disruption to travel caused by an emergency, a lack of access arrangements, or because the school premises are closed

5.2 Legal sanctions

Our school will make use of the full range of potential sanctions – including, but not limited to, those listed below – to tackle poor attendance. Decisions will be made on an individual, case-by-case basis.

Penalty notices

The headteacher (or someone authorised by them), local authority or the police can fine parents for the unauthorised absence of their child from school, where the child is of compulsory school age, by issuing a penalty notice.

If the school issues a penalty notice, it will check with the local authority before doing so, and send it a copy of any penalty notice issued.

Before issuing a penalty notice, the school will consider the individual case, including:

- Whether the national threshold for considering a penalty notice has been met (10 sessions of unauthorised absence in a rolling period of 10 school weeks)
- Whether a penalty notice is the best available tool to improve attendance for that pupil
- Whether further support, a notice to improve or another legal intervention would be a more appropriate solution
- Whether any obligations that the school has under the Equality Act 2010 make issuing a penalty notice inappropriate

Each parent who is liable for the pupil's offence(s) can be issued with a penalty notice, but this will usually only be the parent/parents who allowed the absence.

The payment must be made directly to the local authority, regardless of who issues the notice. If the payment has not been made after 28 days, the local authority can decide whether to prosecute or withdraw the notice.

If issued with a first penalty notice, the parent must pay £80 within 21 days, or £160 within 28 days.

If a **second** penalty notice is issued to the same parent in respect of the same pupil, the parent must pay £160 if paid within 28 days.

A **third** penalty notice cannot be issued to the same parent in respect of the same child within 3 years of the date of the issue of the first penalty notice. In a case where the national threshold is met for a third time within those 3 years, alternative action will be taken instead.

A penalty notice may also be issued where parents allow their child to be present in a public place during school hours without reasonable justification, during the first 5 days of a suspension or exclusion (where the school has notified the parents that the pupil must not be present in a public place on that day). These

penalty notices are not included in the National Framework, not subject to the same considerations about support being provided, and do not count towards the limit as part of the escalation process.

In these cases, the parent must pay £60 within 21 days, or £120.

Notices to improve

If the national threshold has been met and support is appropriate, but parents do not engage with offers of support, the school may offer a notice to improve to give parents a final chance to engage with support.

Notices to improve will be issued in line with processes set out in the local code of conduct for the local authority area in which the pupil attends school.

They will include:

- Details of the pupil's attendance record and of the offences
- The benefits of regular attendance and the duty of parents under <u>section 7 of the Education Act</u> <u>1996</u>
- Details of the support provided so far
- Opportunities for further support, or to access previously provided support that was not engaged with
- A clear warning that a penalty notice may be issued if attendance doesn't improve within the improvement period, along with details of what sufficient improvement looks like, which will be decided on a case-by-case basis
- A clear timeframe of between 3 and 6 weeks for the improvement period
- The grounds on which a penalty notice may be issued before the end of the improvement period

6. Strategies for promoting attendance

- Class attendance figures will be calculated each Monday morning for the previous week and published on the website. These figures are shared in the weekly Thursday attendance assembly and the class with the highest percentage winning an extra 5 minutes playtime.
- Certificates and badges will be given out termly to children who have the most improved attendance
- Parents/carers will be contacted either by phone or letter informing them of an improvement in attendance

7. Supporting pupils who are absent or returning to school

Pupils absent due to mental or physical ill health or SEND

Where a pupil has an education health and care (EHC) plan and their attendance falls, or the school becomes aware of barriers to attendance that related to the pupil's needs, the school will inform the local authority.

8. Attendance monitoring

8.1 Monitoring attendance

The Attendance Manager (the Deputy Head) will monitor attendance and absence data (including punctuality) half-termly, 10 week cycles, termly and yearly across the school and at an individual pupil, year group and cohort level.

Specific pupil information will be shared with the DfE on request. The school has granted the DfE access to its management information system so the data can be accessed regularly and securely.

Children may be monitored more regularly if they are persistent absentees. Teachers who are concerned by a child's attendance may bring this to the attention of the Deputy who will then investigate the issue.

- Initially, if a child's absence level is noticed, the parents of the child will receive a phone call from the
 deputy head teacher informing them of the school's concerns and set out aims for attendance moving
 forward and to offer support if necessary.
- If a child's absence becomes a continued concern, parents receive a letter to inform them of the school's concern and to set an attendance target.
- Sustained poor attendance will lead to an Attendance Meeting at school which will be attended by the parent, Deputy and when necessary, the DSL or EWO.
- If attendance continues to be a concern the Deputy can then refer the child to the authority who will determine the next course of action.

Data will be collected each term and published at national and local authority level through the DfE's school absence national statistics releases. The underlying school-level absence data is published alongside the national statistics.

The school will benchmark its attendance data at whole school, year group and cohort level against local, regional, and national levels to identify areas of focus for improvement, and share this with the governing board.

8.2 Analysing attendance

The school will:

- Analyse attendance and absence data regularly to identify pupils, groups or cohorts that need additional support with their attendance.
- Identify pupils whose absences may be a cause for concern, especially those who demonstrate patterns of persistent or severe absence
- Conduct thorough analysis of half-termly, termly, and full-year data to identify patterns and trends
- Look at historic and emerging patterns of attendance and absence, and then develop strategies to address these patterns

8.3 Using data to improve attendance

The school will:

• Provide regular attendance reports to teachers and our pastoral teacher, to facilitate discussions with pupils and families

• Use data to monitor and evaluate the impact of any interventions put in place in order to modify them and inform future strategies

8.4 Reducing persistent and severe absence

Persistent absence is where a pupil misses 10% or more of school, and severe absence is where a pupil misses 50% or more of school. Griffin Park recognises that children who persistently have low attendance are more vulnerable and thus at risk of harm.

Regular meetings take place between the Deputy Head and the school's Inclusion Officer to identify children who might be at greater risk due to non- attendance. Meetings with parents are arranged, either at school or at the family home and targets for improvement are set. In some cases we may use a 'fast track to attendance pathway' to improve attendance. If children fail to improve their attendance, then the school will follow the procedure of applying for a Penalty Notice.

The school will:

- Use attendance data to find patterns and trends of persistent and severe absence
- Build strong relationships with families, listen to and understand barriers to attendance and work with families to remove them
- Provide Early intervention
- Consider potential safeguarding issues and, where suspected or present, address them in line with Keeping Children Safe in Education
- Monitor the attendance of persistent absentees on a fortnightly basis.
- Work closely with the Pastoral Worker to support children and families with recurring patterns of absenteeism, opening a CAF if it is deemed that the family need support.
- Identify Emotionally Based School Avoidance (EBSA)
- Contact families of children with poor attendance by phone to determine reasons for absence. This is followed by a letter setting attendance targets if attendance continues to cause concern.
- Hold regular meetings with the parents of pupils who the school (and/or local authority) considers to be vulnerable or at risk of persistent or severe absence, or who are persistently or severely absent, to:
 - o Discuss attendance and engagement at school
 - o Listen, and understand barriers to attendance
 - o Explain the help that is available
 - o Explain the potential consequences of, and sanctions for, persistent and severe absence
 - Review any existing actions or interventions
 - Provide access to wider support services to remove the barriers to attendance
 - Hold regular meetings between the Deputy Head and the school's Inclusion Officer to identify
 children who might be at greater risk due to non- attendance. Meetings with parents are arranged,
 either at school or at the family home and targets for improvement are set. Consider alternative
 support that could be put in place to remove any barriers to attendance and re-engage these pupils.
 In doing so, the school will sensitively consider some of the reasons for absence
 - Implement sanctions, where necessary (see section 5.2, above)

9. Children missing in Education (CME)

9.1 Although not exhaustive, the list below identifies categories of vulnerable children who are at particular risk of going missing from education:

- Children at risk of Child Sexual Exploitation (CSE)
- Children at risk of forced marriage
- Children at risk of Female Genital Mutilation (FGM)
- Children living in women's refuges
- Children in homeless families, perhaps living in temporary accommodation, houses of multiple occupancy or Bed & Breakfast accommodation
- Children at risk of extremism and radicalization
- Children from Gypsy/Roma/Traveller background
- Children of Armed Services Personnel
- Children with long-term medical or mental health needs
- Children who have particular social and behavioural difficulties and have personalised learning plans: this means that, by arrangement, they do not attend their usual school full-time
- Children who have complex needs and no suitable school place is available
- Looked after Children (LAC)
- Children in private fostering arrangements
- Young carers
- Children from transient families, i.e. pupils who have experienced high levels of mobility between different education providers
- Children permanently excluded from school
- Children informally excluded from school and/or those placed on long-term part time timetables
- Children of statutory school age who rarely attend school and have personalised learning plans as part of attempts to reintegrate them into full-time education
- Children taken off their school roll further to failure to return from unauthorised (or authorised) leave of absence
- Children entering or leaving the independent schools sector
- Unaccompanied asylum seekers and refugees, or the children of asylum seeking families
- Children of new migrant families and EC nationals who have the right of abode in the UK this now
 includes a significant number of asylum seekers granted status by other EC countries and who have
 subsequently moved to the UK

• Others who have come from abroad to live and/or work in the Borough and are waiting for a school place.

This Policy recognises the importance of reducing the risk of children missing from education. Griffin Park follows the policy of Blackburn with Darwen for recording and reporting children who are absent from school for more than 10 days.

The Inclusion Team are informed when children are moving from one school to another and children are only deleted from role under the authority of the Inclusion Team, to ensure that children are safeguarded.

10. Monitoring

This policy will be reviewed as guidance from the local authority or DfE is updated, and as a minimum every 2 years by the deputy head. At every review, the policy will be approved by the full governing body, represented by the Health and Safety Committee.
